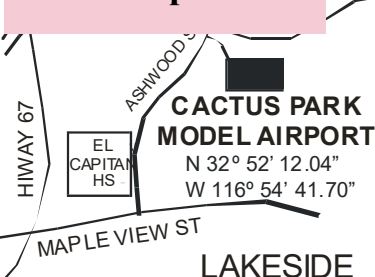

President's Message July 2020

RF Interference

This was a focus for the last couple of months. Since the two weeks in May that we observed many hits, I've only had a report of one in the later part of June.

Scanning the area of our field, I recalled that there are several cell repeater towers at the rodeo grounds along Maplevue St. Generally, our field is blocked from a direct line-of-sight of those antennas, however mapping out the topography, it's possible that flying up around 130 ft above the runway, we may be open game for some mal-tuned cell tower. I'm not confident that this is a source of interference, but it's possible. The photos I've included are of the cell towers at the rodeo (there are two in the photo, one on each side of the red banner), and an image of the line of sight between those antennas and our flying site just as the line crosses over the hill.



COVID-19 Protocol

The Supervising Park Ranger and I had a chat recently, and they've adopted a revised COVID-19 protocol that they've asked us to post. Oddly, the protocol template is a DAY CAMP SAFETY PROTOCOL geared towards youth sports. I guess it's the best they have for the new processes of opening up certain county facilities.

The guidance I was given is to simply tailor the protocol as it applies to our activities. That protocol is posted on our bulletin board, and was sent out by email recently.

Also posted at the field is the very latest California Department of Public Health GUIDANCE FOR THE USE OF FACE COVERINGS (dated 18 July 2020). That document was also recently sent out by email.

I believe we'll also have these posted on the club website Downloads area.

Ron Keith, our Safety Officer, stocked the field with disinfectant cleaners, paper towels, nitrile gloves and hand sanitizers. Members are encouraged to wipe down tables and chairs after use. If members are concerned that we're not keeping up with that practice, it's very easy to clean and disinfect the table and chairs you plan to use upon your arrival.

Please use the sanitization cleansers to wipe down the bathroom handle, soap dispenser and seat after you use it. It just takes a second. And if you're opening the safety cabinet in the morning, give the locks and handle a wipe.

As was before, the California Department of Public Health requires that we must wear face coverings "while outdoors in public spaces when maintaining a physical distance of 6 feet from persons who are not members of the same household or residence is not feasible."

It's important that we observe this requirement. You must have a mask on your person, and if you approach someone to within six feet, put it on.

If by chance you notice that someone doesn't have a mask on, and they are approaching you to within six feet, you may step back from them and remind them that they shouldn't approach another person within six feet without a mask.

Rules Change Thank you to all who voted on the recent proposal. The proposal was to revise Rule 6 to shift the early-start time for electric powered planes and gliders from 8:00 AM to 7:00 AM. The revision was approved 51 in favor, 2 opposed. Engine propelled models still start no earlier than 9am. The rule change will be posted on the web site. The rules posted at the field on the large 4'x8' sign will likely have a pen/ink change for now. No sense in spending \$15 for a new vinyl print for a single digit, right?
